ORDER

On March 23, 2017, the Court entered a scheduling order requiring all individual plaintiffs to submit a Plaintiff Profile Form (PPF) to BrownGreer PLC within 30 days of newly filing a case in the Abilify MDL. *See* ECF No. 273. In Case Management Order No. 14, the Court extended this deadline for all then-filed cases to June 23, 2018 and advised that a plaintiff's failure to timely submit a completed PPF to BrownGreer would result in sanctions, up to and including dismissal of a case. *See* ECF No. 901. Thereafter, the Court determined that additional information was needed from all individual plaintiffs, beyond that provided on the initial PPFs, and directed all plaintiffs to submit a completed Supplemental Plaintiff Profile Form (SPPF), along with supporting documentation, to BrownGreer by October 31, 2018 or within 60 days after the date their case was first docketed in this district. *See* ECF No. 986. As with the PPF, the Court advised that failure to timely submit a completed SPPF and supporting documentation would result in sanctions, up to and including dismissal of a case. *See id.*

The Court has now confirmed that over 400 individual plaintiffs have failed to comply with these directives by either: (1) failing to timely submit both a PPF and a SPPF; (2) failing to submit one or the other of these forms; or (3) submitting blank and/or incomplete forms.¹ As the time for compliance has lapsed, the Court finds it necessary to enter a show cause order in all of these individual cases. Failure to comply with the show cause order will result in dismissal of a case with prejudice, without further order of the Court. *See In re Phenylpropanolamine (PPA) Prod. Liab. Litig.*, 460 F.3d 1217 (9th Cir. 2006) (affirming dismissals of individual cases with prejudice for failure to comply with case management orders by failing to timely file Plaintiff Fact Sheets and/or records authorizations, despite repeated instructions to do so).

Accordingly, it is **ORDERED** that:

1. Defendants' Motion for Entry of Order to Show Cause Regarding Plaintiffs with Missing Plaintiff Profile Forms and/or Supplemental Plaintiff Profile Forms, ECF No. 1102, is **GRANTED** as to the individual plaintiffs identified in Exhibit A.
2. All individual plaintiffs identified in Exhibit A are hereby **ORDERED** to show cause why his or her case should not be dismissed with prejudice for failure to comply with an order of the Court, by **February 7, 2019**. Each plaintiff's response to the show cause order must be filed on the docket for his or her individual case only. Importantly, at this late juncture, the mere submission of the requisite materials to BrownGreer PLC will not satisfy this show cause obligation. If the

¹ A PPF and/or Supplemental PPF is complete where accurate and responsive answers are provided to every question on the form, including the type and amount of damages. The SPPF must be signed by each plaintiff under penalty of perjury.

Court finds that good cause is shown in an individual case, then a short deadline will be set for that plaintiff to submit a completed Plaintiff Profile Form (PPF) and Supplemental Plaintiff Profile Form (SPPF), along with supporting documentation, to BrownGreer PLC.

3. Failure to comply with this Order will result in dismissal of a case with prejudice.
4. The Clerk is directed to enter a copy of this Order on the individual docket for each of the cases identified in Exhibit A.
